SCHOOL FEE PAYMENT INFORMATION

- Kids Academy Africa Senior School is a fee paying school. By enrolling your child at KAA, you are accepting the obligation to contribute financially towards your child's education. You are therefore expected to pay the fees in full according to whichever school fee payment option selected hereon.
- School fees are paid in advance and must be paid by the 1st of every month.
- In the event of divorce, irrespective of the divorce agreement, both parents will be held responsible for the fees and must therefore both sign the application form.
- Should you be in breach of contract for delayed payments, a letter of demand subject to a penalty fee of R150-00 will be sent to you around the 5th of every month. If payment is not received, interest of 24% will be charged on outstanding fees. Your child could be suspended until the matter is resolved or deregistered if the matter is ongoing.

Please see our school fee payment options below. Please note, once you have entered into a payment plan, you cannot deviate from it. It will need to be honoured for the duration of the plan.

Option 1 - Monthly Payments over 12 months:

12 months x R2500-00 per month

Option 2 – Payment over 11 months:

(06h45 – 14h30) R30 000-00 per annum
11 months x R2727-27 per month

Option 3 – Payment over 10 months:

10 months x R3000-00 per month

Option 4 – Upfront payment for the whole year.

Fees to be paid by the 01st of October 2024 to claim 7% discount.
